21/082 To receive apologies from Members not able to attend the meeting.

Apologies was received from Ward Cllr Jackson.

21/083 Declaration of Interest (Model Code of Conduct Order 2012).

Cllr Pettigrew declared a Personal Interest in Agenda Item 21/087 Whitsend Farm and Planning matters 21/089 a) DM/1073/21/FULA.

21/084 Questions raised by members of the public on agenda items (15minutes).

None in attendance.

21/085 To approve the Minutes of the Meetings held on 4th October 2021.

To consider and approve the minutes held on 4th October 2021.

RESOLVED: The minutes were approved as a true record and the Chair signed them.

21/086 Police Report

The Police were unable to attend the meeting, but a Police Report was submitted. The clerk distributed copies of the report to Councillors prior to the meeting. There have been fourteen crimes reported in the Waltham Ward.

RESOLVED: Clerk to place Police Report on the Notice Board and Website.

21/087 Highways / Public Footpaths / Items Carried Forward:

- 09/104 Whitsend Farm – Chair said that this item could be deferred until the end of the meeting due to Cllr Pettigrew declaring an interest.
- 20/072 FP89 Safety Issues – NELC Footpath Officer has recently spoken to the Ramblers about the path though it is not ideal it is still walkable. It is on the officer's list of jobs. Noted
- 20/112-2 The Stables – The Magistrates hearing on 24th September was adjourned until 11am on 19th November to allow the defendant time to seek legal advice. Noted.
- 21/044-3 Ward Funding Projects – Cllr Pettigrew advised that he has received the flagpole and will place in situ when the trees on the village green are cut back. **RESOLVED: Flagpole to be placed in situ when the trees on the village green are cut back**

- 21/055-4 Minor Highways Scheme suggestions – Clerk advised that at her meeting on 20th October with Highway Officer Debbie Swatman she reported that three bollards are bent at the top of Ashby Lane and that the tactile paving in this area is covered in mud. She also mentioned that the hedge along the Main Road B1203 required a cutback as it was overhanging the highway. **RESOLVED: The three concerns have been reported to NELC relevant departments.**
- 21/055-5 Village Green – The tree work on the village green starts on Tuesday 9th November. Cllr Pettigrew mentioned that he has not seen any documentation come through for the three trees that have TPO's on them. **RESOLVED: Clerk to check with Tree Surgeon that all paperwork has been completed.**
- Newsletter – Cllr Hornby advised that he has received the non-political article from MP Martin Vickers. He agreed to forward to Councillors so that they can approve. **RESOLVED: Clerk to finalise the Newsletter and distribute to Councillors at December's meeting**

21/088 Items for Discussion:

1. Ward Funding – Clerk advised that she has received confirmation that the ward funding has been approved. **RESOLVED: Clerk to place order for new laptop.**
2. HGV Vehicles along Thoroughfare – Resident reported that an HGV vehicle damaged the electric cable on the side of her dwelling and had to use a generator for power until electric company could make relevant repairs. She said that there has been an increase in heavy goods vehicles using Thoroughfare. Due to an accident on the A16 a diversion was set up which created the increase in vehicles. **RESOLVED: Clerk to contact the resident to see if she can obtain the company name of future HGV's that use Thoroughfare which will enable the Parish Council to contact them.**
3. Brass plaques mounted of Village Signs – Clerk advised that a resident has asked what the procedure is if they wished to place a plaque on the village signs. This highlighted the need for a Councillor to volunteer to take on the job of ordering and fitting the plaques. **RESOLVED: Cllr C. Shaw agreed to take on this role.**
4. Clerk Vacancy – Councillors agreed that the vacancy should be advertised. **RESOLVED: Clerk to make relevant arrangements and place on the notice board, website, Facebook and forward information to ERNLLCA to share with their members.**
5. Chair advised that yesterday a fallen tree blocked the road and that he saw Mr and Mrs Griffin removing the tree off the road. He suggested a thank you letter is sent. **RESOLVED: Clerk to send thank you letter.**
6. Increase frequency of recent power cuts – Councillors discussed the increasing frequency and time length of current power cuts within the village. **RESOLVED : The Parish Council agreed to write to Northern Power Grid to ask why the power cuts have increased.**
7. The Parish Council raised concerns regarding the number of books in the telephone box and the untidy state. **RESOLVED: The Chair agreed to ask his wife to have a look.**
8. Cllr Hornby mentioned that the refuse bin on the village green needed cleaning. **RESOLVED: Cllr Hornby agreed to clean the bin.**

Waltham, Brigsley & Ashby-cum-Fenby November Update

Crime

There were fourteen crimes reported during October for the Waltham Ward. Of these, the following offences have occurred.

During the early hours of 18th October two burglaries were committed on Danesfield Avenue. At one premises, an attempt was made to enter the garage. No entry was gained; however, the intruders turned their attention to a wooden shed. Entry was gained and tools and fishing equipment was stolen.

At the second property, the garage was broken into, and two bikes were stolen.

Over the same period of time as the burglaries, and also on Danesfield Avenue, a wildlife camera was stolen from the garden.

During the early hours of 15th October windows were smashed on a HGV unit parked on Waltham Airfield to gain entry. The vehicle has then been driven on the airfield, smashing through gates and causing damage to other property. The vehicle was then set alight. There was also a domestic related criminal damage reported.

Other crime includes:

Two assaults.

Three offences of sending malicious communications.

One minor public order offence.

There has been one report of ASB.

Youths playing 'knock door run' on Neville Turner Way.
